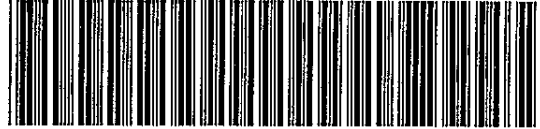

**ARTICLES OF ORGANIZATION
OF
BROWN'S BAYOU LANDING, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be BROWN'S BAYOU LANDING, LLC.

ARTICLE II- ADDRESS

The mailing address and street address of the principal office of the company is 400 Colbert Avenue, Pensacola, FL 32507.

ARTICLE III - DURATION

The company shall commence its existence effective upon filing of these articles with the Secretary of State of Florida. The company's existence shall be perpetual, unless the company is dissolved earlier as provided in the company's regulations.

ARTICLE IV - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the State of Florida is PATRICK F. BROWN, 400 Colbert Avenue, Pensacola, FL 32507.

ARTICLE V - CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company the cash or property set forth in Exhibit "A".

ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company upon consent of all the members, or as otherwise provided in the regulations.

ARTICLE VII - ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the then members of the company and on such terms and conditions as shall be determined by the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company, or become a member unless all the members of the company other than the member proposing to dispose of his or her interest, approve of the proposed transfer.

ARTICLE VIII - MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by consent vote of all the remaining members.

ARTICLE IX - MANAGEMENT

The company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulations and management of the affairs of the company not consistent with law or these articles of organization. The name and address of the initial manager of the company is PATRICK F. BROWN, 400 Colbert Avenue, Pensacola, FL 32507.


