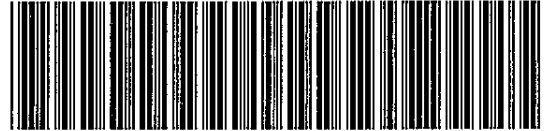

The name of the limited liability company is Woodbine Commons Commercial, LLC.


Article II - Address
