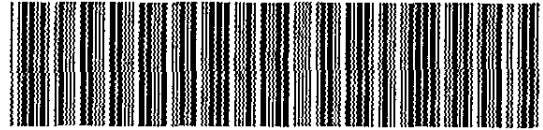

ARTICLE I NAME

The name of this Professional Limited Liability Company is : Speed & Company, CPA, P.L.L.C.

ARTICLE II ADDRESS

The mailing address and street address of the principal office of the Professional Limited Liability Company is: 773 Glendale Street, Lakeland, Florida 33803.

ARTICLE III PURPOSE


