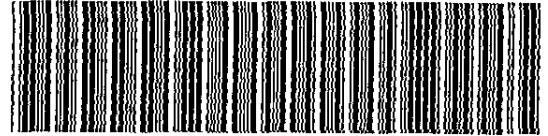



**ARTICLE II – PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**




