ARTICLE I

NAME

The name of the limited liability company shall be:

The Manager shall be authorized to incur any liability on behalf of the limited liability company.

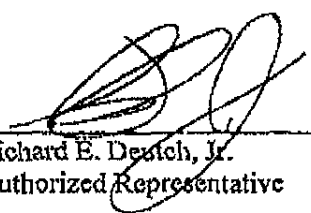
