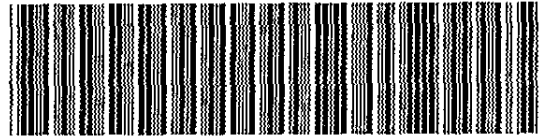

1. NAME. The name of the limited liability company is POSH, LLC.
