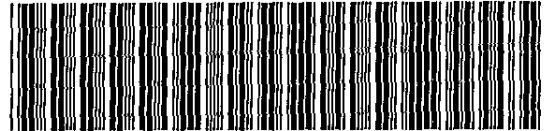

ARTICLE I -- NAME
