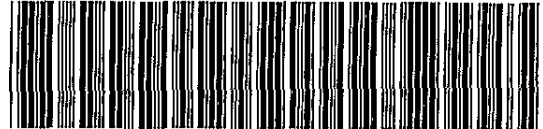


ARTICLE 4 – Management. The company shall be managed by its managers and not its members. The initial managers of the company shall be:
