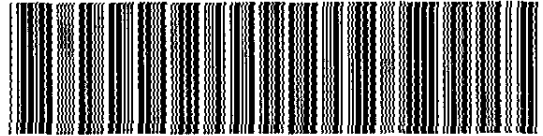

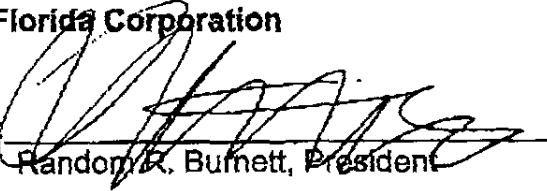
ARTICLES OF MERGER

- (d) The effective date of the merger is the date of filing of the Articles of Merger with the Florida Department of State.

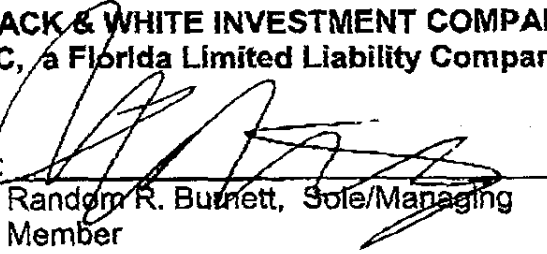

1. This Plan of Merger is between **BLACK & WHITE INVESTMENT COMPANY, a Florida Corporation** and **BLACK & WHITE INVESTMENT COMPANY, LLC, a Florida Limited Liability Company** formed and organized under the laws of the State of Florida.

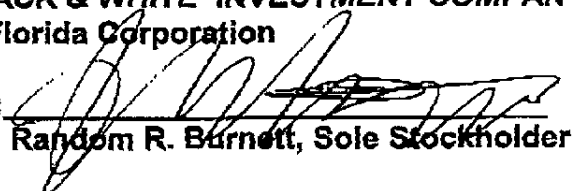

6. The effective date of the merger will be on the date of filing the Certificate of Merger with the State of Florida.

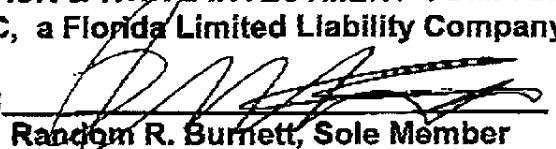
