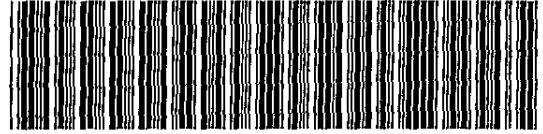

MANAGEMENT

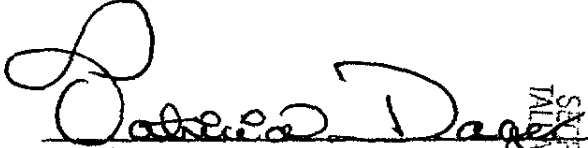
