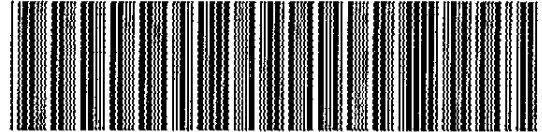





- a) Sue and be sued, and defend, in its name.
- b) Purchase, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal with real or personal property, or any legal or equitable interest in property, wherever located.
- c) Sell, convey, mortgage, grant a security interest in, lease exchange, and otherwise encumber or dispose of all or any part of its property.
- d) Purchase, receive, subscribe for or otherwise, acquire, own, hold, vote, use, sell, mortgage, lend, grant a security interest in, or otherwise dispose of and deal in and with, share or other interests in or obligations of any other entity.
- e) Make contracts or guarantees or incur liabilities; borrow money; issue its notes, bonds, or other obligations, which may be convertible into or include the option to purchase other securities of the limited liability company; or make contracts of guaranty or surety ship which are necessary or convenient to the conduct, promotion, or attainment of the business of a corporation the majority of the outstanding stock of which is owned directly or indirectly, by the contracting limited liability company; a corporation which owns, directly or indirectly, a majority of the outstanding membership interest of the contracting limited liability company; which contracts of guaranty and surety ship shall be deemed to be necessary or convenient to the conduct, promotion, or attainment of the business of the contracting limited liability company; or make other contracts of guaranty and surety ship which are necessary or convenient to the conduct promotion or attainment of the business of the contracting limited liability company.
- f) Lend money, invest or reinvest its funds, and receive and hold real or personal property as security for repayment.
- g) Conduct its business, locate offices, and exercises the powers granted by this chapter within or without this state.
- h) Select managers and appoint officers, directors, employees, and agents of the limited liability company, define their duties, and fix their compensation and lend them money and credit.
- i) Make donations for the public welfare or for charitable, scientific, or educational purposes.
- j) Pay pensions and establish pension plans, pension trust, profit sharing plans, bonus plans, option plans, and benefit or incentive plans for any or all of its current or former managers, members, officers, agents, and employees.
- k) Be a promoter, incorporator shareholder, partner, member, associate, or manager of any corporation, partnership, joint venture, trust or other entity.
- j) Make payments or donations or do any other act not inconsistent with law that furthers the business of the limited liability company.

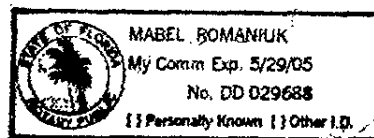
