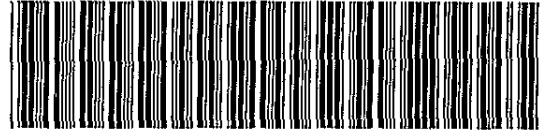

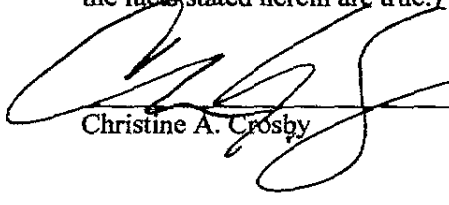
The existing members of this LLC must approve the admission of new members by unanimous vote. Upon such approval, new members shall be accorded all rights associated with membership in this LLC.

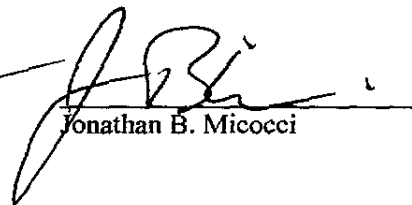
ARTICLE VI - MEMBER'S RIGHT TO CONTINUE BUSINESS.
