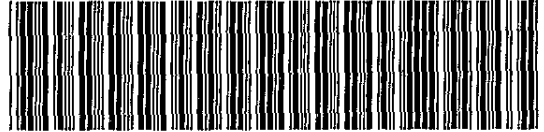





**CERTIFICATE OF TRUST  
OF THE  
JOCELYN C. BLAYLOCK REVOCABLE TRUST**

THIS CERTIFICATE OF TRUST is executed and delivered to certify to the execution and continued existence of a certain Revocable Trust Agreement executed by me, JOCELYN C. BLAYLOCK, as Grantor, on November 16, 1999 and restated and amended December 17, 2003 (the "Trust"), whose social security number is 340-60-5763 wherein I am the initial Trustee. Upon the death, resignation, incapacity or other inability of me to continue to serve as a Trustee hereunder, my sister, JACKIE BLAYLOCK SMITH ("JACKIE"), and my attorney and friend, JEFFREY B. KAHN ("JEFFREY"), shall serve as Trustees. Upon JACKIE's death, resignation, incapacity or other inability to continue to serve as a Trustee hereunder, she shall be succeeded by my sister, GWEN BEEBY ("GWEN"). Upon the death, resignation, incapacity or other inability of the survivor of JACKIE, GWEN or JEFFREY to continue to serve as a Trustees hereunder, he or she shall be succeeded by such individuals and/or bank or trust company (or any combination thereof) as GWEN may designate in her Will or other instrument in writing.

Certain of the trust provisions contained in the Trust are as follows:

**RIGHT TO REVOKE AND OTHER RIGHTS RESERVED**

I reserve the right, at any time or times, by an instrument in writing signed by me, to alter, amend or revoke this Trust in whole or in part.

**POWERS OF THE TRUSTEE**

I grant to Trustees (including any successor) the power to sell, mortgage, purchase or grant or acquire options to purchase and convey any security or property, real or personal, held in this Trust, at public or private sale, and at such time and price and upon such terms and conditions (including credit) as my Trustees may determine. I also grant to Trustees every power granted to a Trustee under Chapter 737 of the Florida Statutes and all power and authority contained in any deed conveying real property into this Trust as such power or authority applies to such real property. I also authorize my Trustees to open and maintain an account or accounts for the purchase and sale of securities, whether in cash or on margin, and to hold securities in the name of a nominee.


**REGARDING SUCCESSION OF TRUSTEE**

Any person shall upon request deliver, transfer and pay over assets of this Trust to a Successor Trustee named herein upon presentation of a certificate, signed under oath by the Successor Trustee certifying to the death, incapacity or resignation of the prior Trustee, without any duty on the part of such third party to inquire into the accuracy of such certificate, and any person relying upon such certificate from the Successor Trustee shall be fully protected.




