

EXHIBIT A

AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF R & T 826 BLANDING, LLC

These Amended and Restated Articles of Organization are submitted in accordance with the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as the same may from time to time be amended (the "Act"). Although these Amended and Restated Articles of Organization are being filed effective as of the date of filing herewith the Secretary of State of the State of Florida, these Amended and Restated Articles of Organization are intended to reflect the intent of the members on the date of filing of the original Articles of Organization.

ARTICLE I NAME

The name of the limited liability company (the "Company") is: R & T 826 Blanding Blvd., LLC.

ARTICLE II ADDRESSES

The mailing and street address of the Company is 8286 Western Way Circle, Suite C-2, Jacksonville, Florida 32256.

ARTICLE III REGISTERED AGENT

The name and street address of the initial registered agent of the Company are William Wiener, 8286 Western Way Circle, Suite C-2, Jacksonville, Florida 32256.

ARTICLE IV MEMBERS

The initial members of the Company and their percentage interests in the Company are:

(a) ROSE WIENER KANNER (formerly known as ROSE WIENER SAFER), fifty percent (50%); (b) Toby Property, Ltd., a Florida limited partnership, fifty percent (50%). The members of the Company may transfer their membership interests in the Company only in accordance with and subject to the terms, conditions and restrictions of the operating agreement of the Company adopted by the members.

ARTICLE V MANAGEMENT

The Company is to be managed by one or more managers and is, therefore, a managermanaged company. The manager shall manage the Company in accordance with the terms and conditions of the operating agreement of the Company.

ARTICLE VI LIMITED LIABILITY

Except as otherwise expressly provided by the Act, no member, manager, officer, agent or employee of the Company shall be personally liable for the debts, obligations or liabilities of the Company, whether arising in contract, tort or otherwise, or for the acts or omissions of any other member, manager, officer, agent or employee of the Company.
