

ARTICLES OF ORGANIZATION
OF

THE UNDERSIGNED, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - NAME

The name of the Limited Liability Company (hereinafter referred to as "Company") is E. D. GREGORY, L.L.C.

ARTICLE II - PRINCIPAL OFFICE
