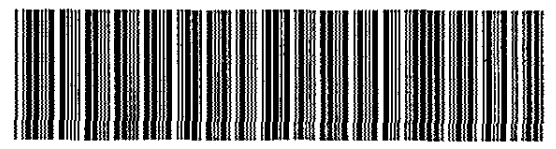




ARTICLE IV
