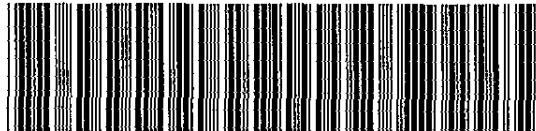

The name of the Limited Liability Company is SOUTH DADE INDUSTRIAL PARK, LLC.




