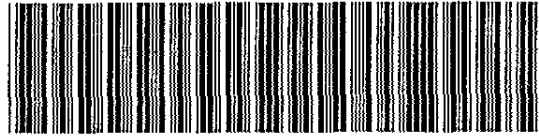

PURPOSE**


