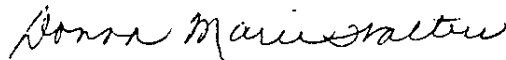

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, provides the following information for the purpose of amending the Articles of Organization of **CURACAO, LLC**, which was formed under the laws of the State of Florida pursuant to Articles of Organization originally filed with the Department of State on February 6, 2004, and assigned document number L04000010449.

1. Article I of the Articles of Organization is amended to read:

**ARTICLE I
