FOR

**ARTICLE 1
NAME**

The name of the limited liability company shall be Sherouse Well Drilling LLC

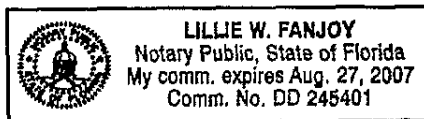
