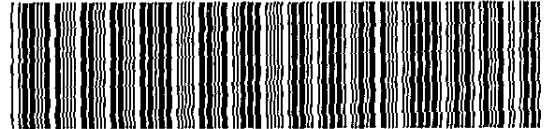


**Article V. Management**
