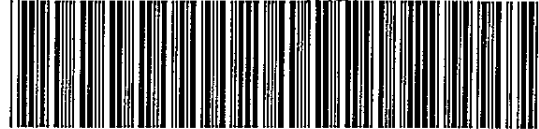



The undersigned, for the purpose of forming a limited liability company pursuant to the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapters 608 and 621, hereby make, acknowledge, and file the following Articles of Organization establishing a Florida "Limited Liability Company."

ARTICLE I -- NAME

The name of the limited liability company shall be JoLor Automotive Group, LLC.

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is 5166 85th St., Vero Beach, FL 32967.

ARTICLE III -- DURATION

The company shall commence its existence on March 1, 2004, or upon the filing date these articles of organization with the Florida Department of State, whichever occurs first. The company's existence shall be perpetual unless the company is dissolved earlier by unanimous written consent of all members as provided in these articles of organization or in any Operating Agreement of the company.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the initial registered agent of the company in the state of Florida are; Thomas A. Kennedy, 370 35th ct. S.W., Vero Beach, Fl, 32968. The registered office of the company shall be; 5166 85th Street, Vero Beach, FL, 32967.

ARTICLE V -- CAPITAL CONTRIBUTIONS

The initial capital contribution of the (2) two initial members of the company shall be \$100.00, Dollars, each, which shall be deposited into the initial operating account of the company. Any capital contribution required of any additional members shall be determined by the unanimous consent of the existing members at the time of the admission of any new member.

Except as set forth in these Articles or any Operating Agreement of the company, no additional members shall be admitted to the company except if they are admitted with the unanimous written consent of all then existing members of the company and on the written terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in these Articles and any Operating Agreement of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by a majority vote of the remaining members.

ARTICLE IX -- MANAGEMENT

The company shall be managed by its' members, through a member/manager in accordance with these Articles or any Operating Agreement of the company adopted by the members for the management of the business and affairs of the company. Any Operating Agreement of the company may contain any provisions for the regulation and management of the affairs of the company which are not inconsistent with law or these Articles of Organization. 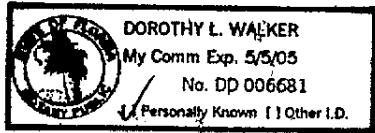
