TO
ARTICLES OF ORGANIZATION
OF

1. **The Entity Name.** The name of the limited liability company is Tampa Affiliated Consulting Services, LLC (the "Company"). The Articles of Organization were filed on March 15, 2004, effective March 12, 2004, and assigned document number L04000019985.

2. **Amendment Adopted.** The amendment adopted provides for the Company to change its name from "Tampa Affiliated Consulting Services, LLC" to "Homebuilder Solutions, LLC".

3. **Text of Amendment.** Article I of the Articles of Organization are hereby amended by deleting such Article in its entirety and substituting in lieu of such Article the following new Article I which reads as follows:

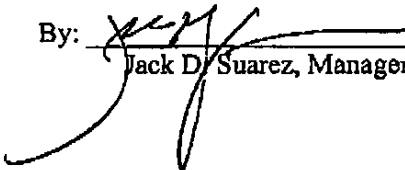
ARTICLE I - Name:
