**ARTICLES OF AMENDMENT
OF
CC MANATEE LAND INVESTMENTS, LLC
(Formerly CC Manatee Development, LLC)**

These Articles of Amendment are executed and made for the purpose of amending and modifying the Articles of Organization for CC Manatee Land Investments, LLC, a Florida limited liability company, formerly named and known as CC Manatee Development, LLC, for the purpose declaring and confirming the merger of Northwest Manatee, LLC into CC Manatee Land Investments, LLC.

Recitals

- A. CC Manatee Land Investments, LLC, formerly named and known as CC Manatee Development, LLC, is a limited liability company lawfully created and existing under the laws of the state of Florida
- B. Northwest Manatee, LLC is a limited liability company lawfully created and existing under the laws of the state of Florida
- C. The members owning all membership interests in CC Manatee Land Investments, LLC ("**CC Manatee Members**") are the same as the members owning all membership interests in Northwest Manatee, LLC ("**Northwest Members**").
- D. The manager of CC Manatee Land Investments, LLC is the same as the manager of Northwest Manatee, LLC.
- E. A plan for merger of Northwest Manatee, LLC into CC Manatee Land Investments, LLC (the "**Merger**") was approved and duly adopted by unanimous vote and approval of all CC Manatee Members and all Northwest Members, providing as stated below:
1. The Merger shall occur and made to be effective on May 5, 2022 (the "**Effective Date**"). The Merger will be absolute and final.
 2. By the Merger, CC Manatee Land Investments, LLC will be the surviving entity, and Northwest Manatee, LLC shall be merged into CC Manatee Land Investments, LLC.
 3. On the Effective Date, the membership interests of Northwest Manatee, LLC shall be converted into an equal number of membership shares of CC Manatee Land Investments, LLC. The converted membership shares shall be subject to all terms and provisions of the Articles of Organization and Operating Agreement of CC Manatee Land Investments, LLC.

THEREFORE, based upon the Recitals stated above, CC Manatee Land Investments, LLC and Northwest Manatee LLC do hereby declare and confirm the merger of Northwest Manatee, LLC into CC Manatee Land Investments, LLC upon and as of the Effective Date of the Merger..

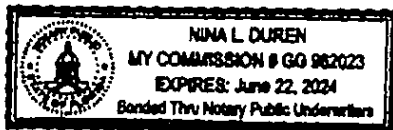

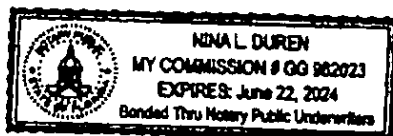
