ARTICLES OF ORGANIZATION
OF

ARTICLE I

The period of duration for the limited liability company shall be perpetual.

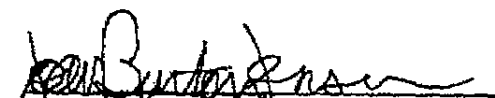
ARTICLE IV
