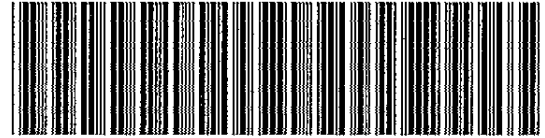



**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF

Mid Florida Car Wash, LLC


2. Article V of the Articles of Organization is hereby deleted in its entirety and is replaced by the following new Article V:
