That the Company shall be dissolved effective immediately.

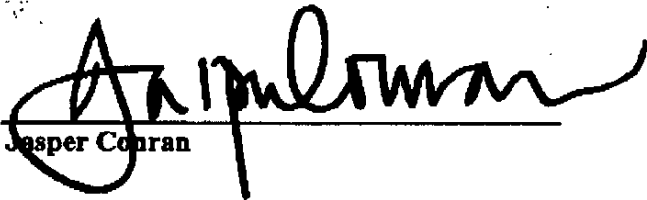
