ARTICLES OF ORGANIZATION OF

The undersigned, ANTHONY J. DeRAIMO, M.D., a natural person competent to contract and a member of RadPET, LLC, hereby presents these Articles of Organization as the Articles of Organization of RadPET, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is:

RadPET, LLC

This limited liability company is referred to in these articles of organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The Company shall be managed by its members.

ARTICLE VIII - RESTRICTION ON MEMBERSHIP


