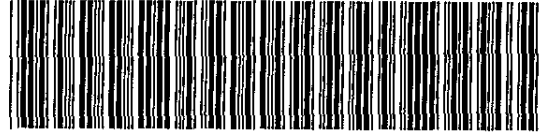

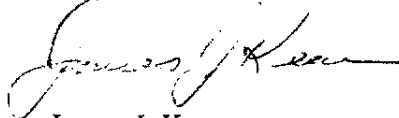

ARTICLE II - ADDRESS

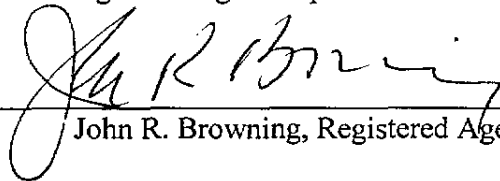

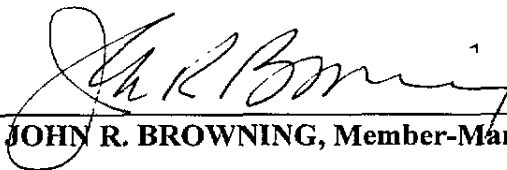
