ARTICLES OF ORGANIZATION OF

LBS 1662, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

In the event additional members are admitted to the company, each member shall make additional capital contributions to the company only on the unanimous consent of all the members.
