**ARTICLES OF ORGANIZATION
OF
MINER ROAD LLC**

The undersigned, for the purpose of forming a limited liability company for profit under the laws of Florida, adopts the following Articles of Organization:

Article I

Name

Section 1.1. Name. The name of this limited liability company shall be MINER ROAD LLC.

Article II

Principal Office and Mailing Address

The members, by vote of members holding a majority of the interests in the limited liability company, shall have the right to amend or repeal any provision contained in these Articles of Organization; provided, however, that it shall require a unanimous vote of members in the limited liability company to amend or repeal Article VIII regarding merger.
