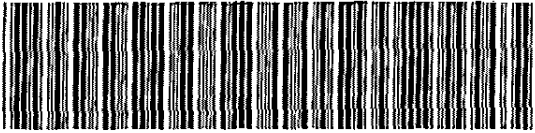



ARTICLE I — Name:


ARTICLE VI

ARTICLE VII


