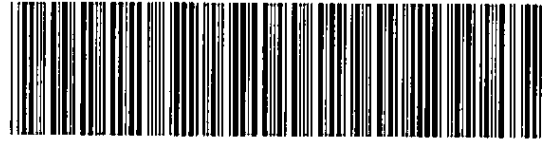

and production of better used land and conservation and soil producing a high quality fresh fruits.


