TAMARAC PARK PLAZA L.L.C.

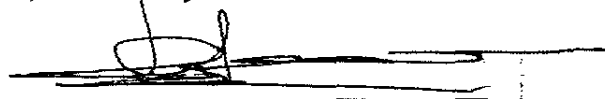
ARTICLE II-ADDRESS

ARTICLE VII- DURATION

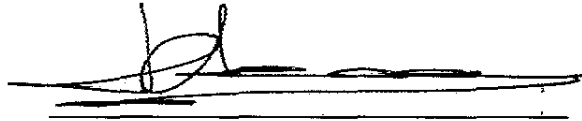
