# Exhibit A to Articles of Amendment of Perlman, Yevoli & Albright, P.L.

1. Article III is amended in its entirety to read as follows:

#### ARTICLE III

The general nature of the business and the proposed objects and purposes to be transacted, promoted and carried on are to do any and all things hereinafter mentioned, as fully and to the same effect and extent as natural persons might or could do, viz:

- 1. To engage in every phase and aspect of the practice of law and to render professional legal services to any and all persons, firms, corporations and other entities, and to the general public, in the State of Florida and all of its political subdivisions and in every jurisdiction and before all courts and public and administrative bodies and otherwise throughout the world, unless prohibited by law.
- 2. To invest its funds in real estate, mortgages, stocks, bonds or other types of investments, and to own real or personal property necessary for the rendering of the aforesaid professional services.
- 3. In general, to do all things and perform all acts necessary and proper for the accomplishment of the aforesaid purposes, or necessary or incidental to the achievement of the objectives of the Company, and to have and exercise all powers of any nature whatsoever permitted or conferred by law upon limited liability companies in general, unless specifically prohibited by the Professional Service Corporation and Limited Liability Company Act of the State of Florida, including any subsequent amendments thereto.
- 4. The foregoing clauses shall be construed both as objects and powers, and it is hereby expressly provided that the foregoing enumeration of special powers shall not be held to limit or restrict in any manner the powers of this Company.
- 2. The following additional Article V is hereby added:

### ARTICLE Y

The following persons shall be the Managers of the Company: Jason E. Perlman, Esq., Mark A. Albright, Esq., and Edward T. Yevoli, Esq.

The following persons shall be the Members of the Company: Jason E. Perlman, P.A., Mark A. Albright, P.A. and Edward T. Yevoli, P.A.
