- FIRST: The Articles of Organization were filed on May 25, 2004 and assigned name No. L04000039662.
- SECOND: The following amendment to the Articles of Organization was adopted by the limited liability company:  
  
Article 1 of the Articles of Organization of the Company is hereby deleted in its entirety and replaced with new Article 1 as follows:  
  
"1. NAME. The name of the limited liability company is DMAN ENTERPRISES, LLC"
- THIRD: Except as hereby amended, the Articles of Organization of the Company shall remain unchanged.
- FOURTH: The foregoing Amendment to the Articles of Organization of the Company was proposed, adopted and approved by the Member and Manager of the Company on October 16, 2012, pursuant to Section 608.4231 of the Florida Limited Liability Act.
