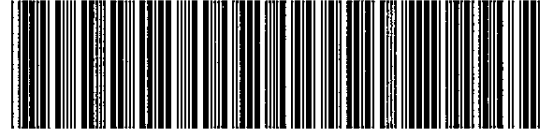

The name of the limited liability company shall be Bay 98, LLC, ("company").


