ARTICLES OF ORGANIZATION OF L&D/J&B FARMS, LLC

- 1. Name. The name of this limited liability company is **L&D/J&B FARMS**, **LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
- 2. <u>Duration.</u> The existence of the Company shall be effective as of June 1, 2004, and shall thereafter be perpetual.

- 7. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
