Article I. Name

The name of this limited liability company is Turtle Grass Properties, L.L.C. (“the Company”).

Article II. Duration

The duration of the Company shall be perpetual.

Article III. Address of Principal Office

The street address of the principal office of the Company is 2039 Centre Pointe Boulevard, Suite 201, Tallahassee, Florida 32308. The mailing address is 2039 Centre Pointe Boulevard, Suite 201, Tallahassee, Florida 32308.

Article IV. Initial Registered Agent and Address

Article V. Admission of Additional Members

Article VI. Members’ Rights to Continue Business

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, the remaining members of the Company shall have the right to continue the business of the Company, provided that all remaining members consent to the continuation and there is at least one remaining member.


**CERTIFICATE OF DESIGNATION OF
