ARTICLES OF ORGANIZATION

OF

REAL TIME GRAPHICS, LLC
a Florida limited liability company

The undersigned, for the purpose of organizing a limited liability company pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Organization, and does hereby agree and certify as follows:

ARTICLE ONE - NAME

The name of the limited liability company shall be REAL TIME GRAPHICS, LLC (the "Company").

ARTICLE TWO - COMMENCEMENT OF EXISTENCE

This Company shall commence existence on the date these Articles of Organization are accepted and filed with the Florida Department of State and shall continue until terminated in accordance with the Operating Agreement of the Company.

ARTICLE THREE - PRINCIPAL OFFICE AND MAILING ADDRESS

The mailing address and the street address of the principal office of the Company shall be 689 Douglas Avenue, Suite 107, Altamonte Springs, Florida 32714.

ARTICLE FOUR - INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of the Company shall be located at 689 Douglas Avenue, Suite 107, Altamonte Springs, Florida 32714 and the initial registered agent of the Company at that address shall be Michael S. Mantovani. The Company may change its registered agent or the location of its registered office, or both, from time to time without amendment to these Articles of Organization.
