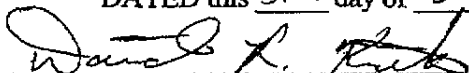
RESOLVED, that the company be dissolved pursuant to Florida Statute §608.441.

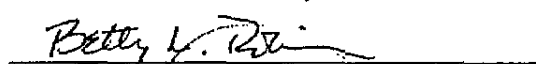

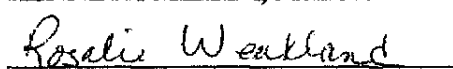
