ARTICLE I - NAME

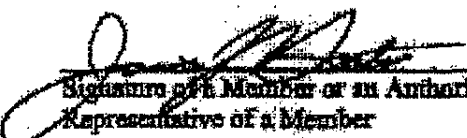
The name of this limited liability company is First Team Air, LLC (the "Company").
