ARTICLES OF ORGANIZATION

ARTICLE ONE NATURE OF BUSINESS

The just valuation of the property contributed to capital shall be fixed by the members at a meeting called for such purpose.

ARTICLE FOUR CONTRIBUTIONS TO CAPITAL

Additional capital contribution to equity, in cash or in property, shall be made from time to time pursuant to the needs of this limited liability company as determined by its members. Additional contributions in the form of loans, whether in cash or in kind, and the terms of these loans, may be made as authorized by the members and upon terms and conditions as agreed upon the members.

The failure to make capital contributions in the capital amount of at the agreed upon due dates shall result in the member in default being dropped and his interest distributed prorate to the remaining member or members.

ARTICLE FIVE ADMISSION OF ADDITIONAL MEMBERS

ARTICLE SEVEN REGULATIONS

The members of the limited liability company may adopt regulations containing all provisions for the regulation and management of this company not inconsistent with law or these articles. ARTICLE TEN TRANSFERABILITY OF MEMBERS' INTEREST


