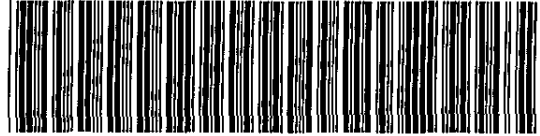

TRAVERSE CITY HOCKEY CLUB, LLC, a limited liability company organized and existing under the laws of the State of Florida (the "Company"), in order to amend its Articles of Organization in accordance with the requirements of Chapter 608, Florida Statutes, does hereby certify as follows:

1. The Articles of Organization of the Company were filed by the Secretary of State of the State of Florida on July 1, 2004.
2. The amendment to the Articles of Organization being effected hereby will completely delete Article I of the Articles of Organization as of the date hereof, and substitute in its place the Article I set forth below.
3. This amendment to the Articles of Organization was approved by the members of the limited liability company on March 24, 2005. The vote was sufficient for approval.
4. These Articles of Amendment to the Articles of Organization shall be effective immediately upon filing by the Secretary of State of the State of Florida, and thereafter, Article I of the Articles of Organization of the Corporation shall read as follows:
