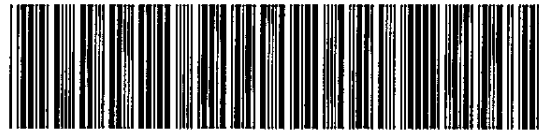

The name of the limited liability company is Watertower Commons, LLC.


**Article II - Address**


