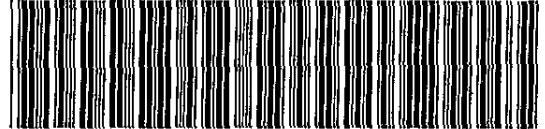

**ARTICLES OF ORGANIZATION**

**OF**

**EZ BUILDER LLC**

The undersigned, being authorized to execute and file these Articles for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization and certify:

**ARTICLE I: NAME**

The name of the limited liability company is EZ Builder LLC (the "**Limited Liability Company**").

**ARTICLE II: ADDRESSES**

The mailing address of the Limited Liability Company is Post Office Box 13881, St. Petersburg, Florida, 33733. The street address of the principal office of the Limited Liability Company is 2716 Sixth Avenue South, St. Petersburg, Florida, 33712.

**ARTICLE III: PURPOSE**

The purpose for which the Limited Liability Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.


**ARTICLE IV: REGISTERED AGENT AND OFFICE**

**ARTICLE VI: MEMBERS AND MANAGEMENT**


