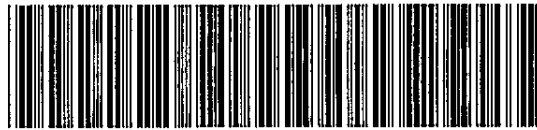


ARTICLE IV
