

ARTICLE VIII - Members Rights to Continue Business:

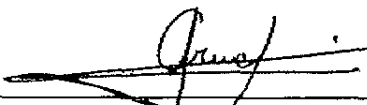
The right, if given, of the remaining Managing-members of the limited liability company to continue the business as a member-managed company in the event of death, retirement, resignation, expulsion, bankruptcy, or dissolution of the Managers of the Limited Liability Company or the occurrence of any other event which terminates the continued membership of the Managers in the limited liability company shall pass to the Managing Members in equal amount of authority.

In the event of the Managers death, retirement, resignation, expulsion, bankruptcy, or dissolution or the occurrence of any other even which terminates the continued membership of the Managers in the Limited Liability Company, all decisions related to the company shall require no less than a majority in interest vote signed by all the Managing Members of the Limited Liability Company.

ARTICLE IX - Emergency Clause

In the event that the Managers cannot readily be assembled because of some catastrophic event, the managing of all the decisions related to the limited liability company shall require no less than a majority in interest vote signed by all the managing- members of the Limited Liability Company.

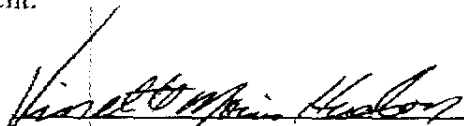
