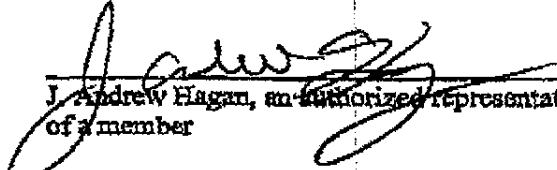
1. The name of the limited liability company is **LIGHTHOUSE KEY INVESTMENT, LLC.**
