ARTICLES OF ORGANIZATION OF UNDERWOOD, EPPLEY & MORRIS, P.L.

The undersigned, for the purpose of forming a professional limited liability company under the Florida Limited Liability Company Act, Fla. Stat. Chapter 608, and Professional Service Corporation and Limited Liability Company Act, Fla. Stat. Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.


ARTICLE IX - MANAGEMENT
